Low-Performing Students Block Grant Plan

The funds will be used to support academic achievement through intervention classes, wellness counseling, and college and career counseling. Academic progress will be closely monitored to identify early signs of needed intervention. The remote year made apparent the access gap and need for targeted intervention and technology resources for our underserved students. The summer intensive program was created to offer small group in person instruction to students in need of credit recovery and skill development. Being able to have an increased number of small group pull out classes or executive functioning skill development groups would further strengthen our college and career readiness programs. The academic progress of all students are monitored and reviewed weekly by members of the academic counseling team. We track effectiveness of our academic supports and interventions based on progress and growth. This year all students have access to a chromebook that includes a student dashboard for textbooks, classrooms, and email. Increased technology access allows every student to have a
