

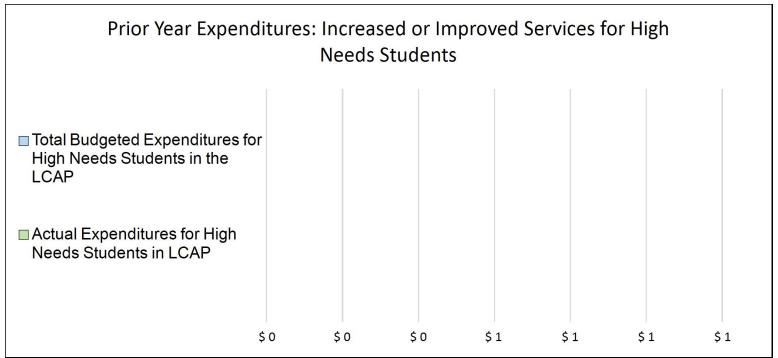

Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Oakland School for the Arts (OSA) balances an immersive arts environment with a comprehensive academic program. Originally, OSA intended to serve the local population with a majority of students being from Oakland and also coming from the greater Bay Area. More recently, we have implemented a lottery system where preference is given to students from Oakland and more specifically to students attending schools with 40% or more student qualifying for free and reduced lunch services. This remains true to the school's original vision. OSA has become a Creative Career Pathways school (Linked Learning Pathways certified) where OSA students are prepared to use their creativity in a wide range of fields and to be successful in many different endeavors. OSA inspires its students to find their individual voices through intensive study of the arts and a challenging academic program that focuses on critical thinking and analysis. Students enter into one of 10 Arts Pathways, receiving 2-3 hours of industry informed specialized arts training daily. We are gradually integrating the CTE curriculum into all of our classes. Graduates are prepared to find success in any field at the college or professional level, including, but not limited to, specialized art schools. With approximately 75% of our graduates gaining acceptance to four-year universities annually, we are confident that this artistic integration into academic programming increases student engagement and student success.

The OSA environment is vibrant, energized and supportive. The arts programs infuse the campus with a great sense of purpose: students are able to pursue their passions and join in a community of like-minded peers that share their sense of creativity and innovation. Equity and inclusion are high priorities, and are reinforced by our Step It Up outreach program to local Title I schools. We also have a preference in admissions to pupils who reside in the elementary school attendance area where we are located, as well as those who attend Oakland elementary schools who meet the Charter School Facility Grant Program Free and Reduced Priced Meal requirement. In addition, the school is part of a thriving arts community in Uptown Oakland and opens its doors to everyone for performances and gallery showings. OSA families are great ambassadors for the school and are involved in all aspects of school life.

Looking into the future, the OSA vision is to give the world generations of innovative problem-solvers and critical thinkers who bring the essential value of the arts into whichever career path they choose. With our 20+ year history we now have evidence through student outcomes that arts education is powerful and successful in bringing forth this vision.

Reflections: Successes

The 2022 CAASPP snapshot shows 60.41% of OSA students met or exceeded standards in ELA compared to 35.3% in OUSD. In Math, 36.9% of OSA students met or exceeded standards compared to 25.87% for OUSD.

Chronic absenteeism continues to remain low at OSA. ADA has not recovered to pre-pandemic levels primarily due to enrollment challenges in high school. Despite that, we have successfully kept most of our seniors enrolled and on track, graduating with A-G diplomas.

Graduation rate increased slightly in 2022, from 95% to 96%.

Suspension rate in 2022 is 3.5% with a high level of African American students and students with disabilities being suspended.

Retaining and hiring credentialed teachers continues to be a challenge as we are in a statewide teacher shortage and teachers are leaving the profession at a significant rate.

The dashboard does not display accurate information for Parent and Family Engagement or Local Climate Survey. Our level of family engagement is high and will continue to grow next year with a newly formed PTSA, weekly communication through the OSA Family Newsletter, and engagement with parents through our regular student performances and shows. OSA conducts an annual climate survey with 125 families completing the survey in 2022-23.

Reflections: Identified Need

Math skills development continues to be a challenge for a large percentage of students whose education was disrupted during Covid. In 2023 the math department will transition to a new math curriculum for Algebra I that will lay a strong foundation for more advanced math skills. We also have highly qualified math faculty in place for the coming school year.

Our enrollment challenges mirror challenges shared by all traditional schools post-pandemic and our HS enrollment has declined significantly since 2019. During the pandemic some students shifted to an alternative education path and some families relocated out of state. A focus on increasing enrollment in the 2023 school year is supported through the staffing of a Director of Enrollment, and the elimination of auditions in the 2023 school year will potentially increase our HS transfer numbers. We will continue to focus on engaging all students through relevant, engaging, socially conscious and culturally responsive curriculum in the Arts and Academic programs.

In 2022-23 our suspension rates of AA and students with disabilities continues to be too high. The student support team has reviewed use of suspension to address our most severe disciplinary situations: use of controlled substances and physical altercations. Student mental health and wellness is a top priority for our team and we need to increase resources to provide education around the use of nicotine, alcohol and marijuana. In addition, we need to shift some student attitudes away from using physical violence towards conflict resolution. We intend to do so through mentor and conflict resolution training for the 2023 school year.

While over 90% of our academic faculty are credentialed in the area they teach, we need to support our arts faculty to obtain CTE credentials in their pathways in order to comply with state requirements.

LCAP Highlights

This plan was developed in a pivotal year for the school. Like many schools, we brought out students back to campus after a substantial period of remote learning. This brought forth both predictable and unpredictable challenges that we have navigated as a school community. With increasing mental health needs of all members of our community our support structures have been evolving to support our students and families as we remain committed to the school's mission and vision. In the midst of this challenging year we have successfully negotiated our first CBA with our teacher's union, COSATS. The CBA outlines a commitment to policies, processes and procedures that aim to improve the teaching experience at the school while implementing a salary schedule that provides a 15-20% increase in compensation to most teachers. Also notable, the sudden mid-year resignation of our Executive Director resulted in the implementation of a Senior Leadership Team aimed at increasing transparency and community input on all levels and an ongoing analysis of the most effective leadership structure to move the school forward. This has included a strengthened partnership with our primary parent group, The Alliance of Parents and Teachers (APT),

with a renewed commitment to transparency and collaboration. We are excited to enter the new school year having only grown stronger from each of these challenges.

OSA is committed to a culture of feedback. This is not only a necessary attribute of a healthy community, but also inherent to artistic development. OSA engages in this culture of feedback by providing ongoing opportunities for students, parents, employees, and community members to provide input be present in the school decision making process. Oakland is a city with deep roots in social activism and OSA reflects in the engagement of our educational partners. OSA board meetings provide an opportunity for our immediate community and general public to be engaged in school decision making and provide feedback. We routinely survey our students, parents, and employees to monitor general well-being, appropriate technology access, effective student support structures, school safety measures, guality of artistic and academic programs, school communication strategies, and many other key school functions. Our Parent/Teacher/Student Association (PTSA) is the formal body that supports the school in bringing parent voice forward and present in key decision making. OSA partners with the PTSA in the development of the surveys to ensure the data collected is credible and relevant to all stakeholders. OSA also collaborates with a CTE advisory board that meets each semester. The board is composed of professionals representing the various industries for which our program aims to prepare our students. They act as consultants to ensure industry relevance and also support OSA students in providing access to professional experiences through internships, mentorships, and other job opportunities. We partner with OUSD, our authorizing district, as part of the Measure N initiative designed to prepare all students for both college and career opportunities through CTE offerings. This process embeds district oversight to monitor that our offerings are aligned with the four pillars Linked Learning and that the student outcomes demonstrate successful implementation. Beyond the direct feedback from OUSD this process also provides an opportunity for us to partner with other school sites in Oakland through site visits and collaborative discussions. An additional measure the school has implemented this school year is to build stronger relationships with the general downtown community. We are uniquely positioned right in the heart of downtown Oakland and remain committed to being an asset to our neighbors.

The shift from Challenge Day led to intentional planning for OSA Advisory sessions and small group counseling focusing on empathy, awareness and education to make OSA a safe space for all students.

This year we made significant progress to establish and maintain a positive school culture post Covid. Structures have been put in place to provide short and long term intervention and partnerships with outside resources. The work done to make resources more available and accessible has increased students and families making self referral to support. More students have been taught about consent, healthy relationships, self advocacy and how to navigate a complex systems of resources.

The creation of the rubrics was collaborative and included feedback from all stakeholders. This allowed for many perspectives, identities, and experiences to be included in the formation process. The implementation plan was developed to ensure the same spirit of collaboration. These actions have made the rubrics strong tools of accountability and a strong road map for actionable ways in which OSA can create more equitable systems.

The focus of all affinity groups was to build community as a response to the isolation that many students felt after returning to in-person learning. Therefore, all events (and fundraisers to support them) were meant to bring greater community. All affinity groups were normed on conduct, membership, organizing assemblies, and fundraising efforts to ensure that each group was inclusive and that all events were successfully organized. This allowed for greater collaboration between groups and more inclusive events like the BSOC Affinity Camping Trip.

This year's professional development thread incorporated the arts to be better aligned with the mission of OSA. Additionally, each workshop included tools and action items that could be used in every individual's role as an educator.

Now that each department has established common assessments we will be able to use the data more effectively next year to plan instruction and establish a system for tracking proficiency at each grade level.
